PLANNING RECOMMENDATIONS

- a) WAN/7113/3 – Erection of 9 no 2 bedroom flats and associated works. 1-3 Hans Avenue, Wantage, Oxon OX12 7DB for Mr and Mrs Dykes. (deferred from previous meeting )

Object. The proposed development is overbearing and out of character and not in keeping with the surrounding area. The proposed parking is insufficient.

- b) WAN/20338/3-A – Erection of two fascia signs (Re-submission). Unit 11, Limborough Road, Wantage, Oxon OX12 9AJ for Argos Distributors Ltd

No objection.

- c) WAN/2186/17 –Amendment to approved application WAN/2186/14 to substitute 30 new dwellings with associated parking, landscaping and highway access for 4 no terraces comprising 23 units.
