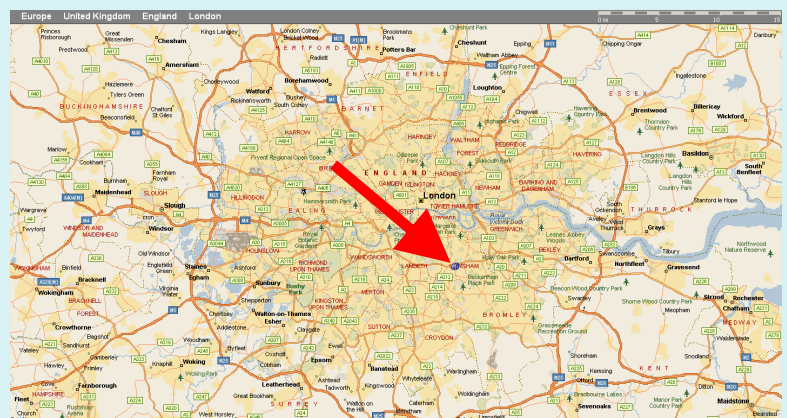
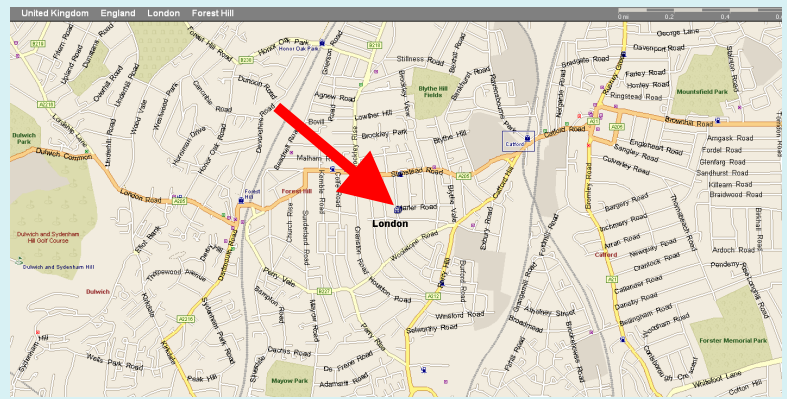
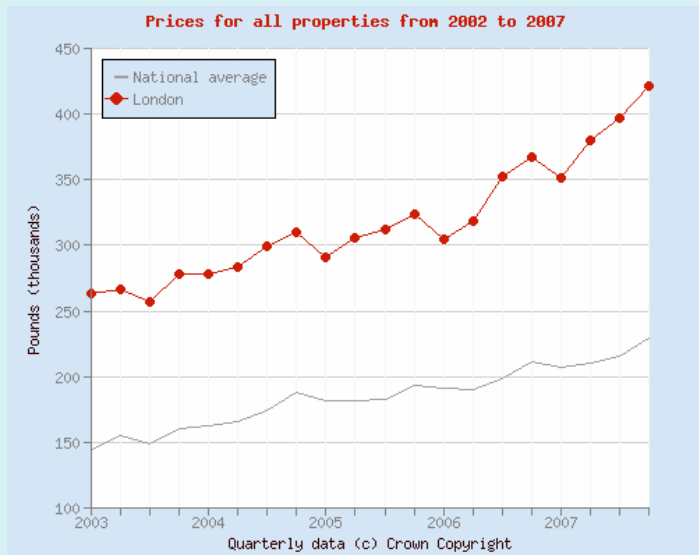
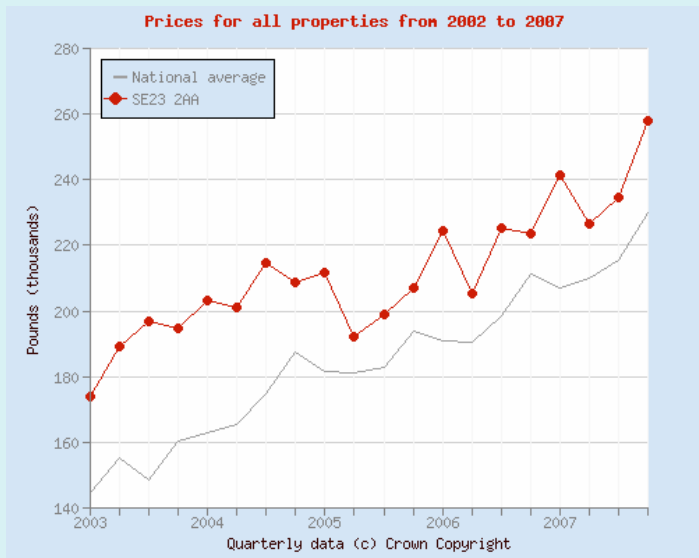




Forest Hill is home to the celebrated Horniman Museum. Despite a leaning toward anthropological and cultural collections, the museum is also home to a newly opened (July 2006) aquarium and one of the most varied collections of taxidermy in the northern hemisphere. Contained within its accompanying gardens is an animal enclosure, flower gardens, and a Grade II listed early 20th century greenhouse. Views from the gardens stretch out over central and north London.

The Hob Public House, opposite Forest Hill station, is a live music and comedy venue. Home to the E.D. Comedy Club, it has attracted acts such as Bill Bailey, Phil Jupitus and Mark Lamarr. Recently renovated, The Dartmouth Arms has been named by The Times newspaper as "one of London's very finest gastro-pubs". Forest Hill Swimming Baths were closed in 2005 due to health and safety concerns surrounding its roof and plumbing. An intrusive survey in October 2006 suggested that a full refurbishment would cost £5.5 million. [citation needed] Lewisham Council recently green-lit the renovation, pledging to fully renovate whilst retaining the building's early 20th century character and original features.

Forest Hill Library is located next to the swimming baths, and in February 2001 hosted 'an evening with J. K. Rowling', attended by children from the local Fairlawn Primary School.
